30 Minute Zoning Resolution Review

Open Items for Discussion

A brief discussion was held on this issue and it was decided that Casey will obtain Licking Townships zoning regulations and Rick would obtain Walnut Townships for review on this issue.

Jeff Zemolong stated that he has had a resident question him as to why toilets or living quarters would not be permitted above boat docks, but it is permitted to bring in a camper. Discussion was held on this issue along with accessory buildings, campers, campgrounds, trailers, boat houses, and Fireman's Park.
