Article XXII.4 - Development Standards Discussion

David Snider, Perry County SWCD Director submitted an email stating his concerns of the township's current language in Article XXII.4. Co-Chair Brad Blain stated that the board should investigate the concerns. Zoning Inspector Ed Corns suggested that Mr. Snider be invited to the next regular meeting to speak to the board about his concerns. It was agreed that Mr. Snider should be invited. Inspector Corns stated that he would reach out to Mr. Snider to see if he was available for November 14th.

Open Items for Discussion

Inspector Corns questioned the board on their feelings of allowing campgrounds in the township in the Rural Business, and if they are interested in that concept, what would they want it to look like. Board member Jim Hay stated that he is not opposed to the idea. Inspector Corns wanted to know, conceptually, what would they want to see. Discussion was held and the items that were mentioned were: Full hookups, electricity availability, and other campground amenities. Inspector Corns stated that a traffic study should be completed and a concept of what would be planned should be supplied to the board to review. Co-Chair Blain agreed that a full-concept plan would be nice to review.
